**Day/Date:** Friday 6<sup>th</sup> August 2021  
**Venue:** Mawson Primary School  
**Time:** Departing Red Hill School at 9.30am  
Return to Red Hill School at 11.30am  
**Transport:** Bus  
**Cost:** *All costs associated with band activities are covered by band fees previously paid*  
**What to Wear:** Students should wear full school uniform  
**What to Bring:** Instrument, music, sunsmart hat and water bottle  
**Teacher in Charge:** Nathan James

Parents will need to ensure that students are at school no later than 9.00am on the day of the excursion.

### **A Covid Safety Plan will be in place for this excursion**

Volunteers and staff will follow the advice of ACT Health and maintain 1.5m physical distance throughout the excursion. If staff, students or volunteers are unwell they must stay home and not attend this excursion. Adults will use the CBR QR code to check-in. Staff, volunteers and students are expected to practise healthy hand and respiratory hygiene. Staff will carry hand sanitiser. Hands will be cleaned before and after eating and activities.
